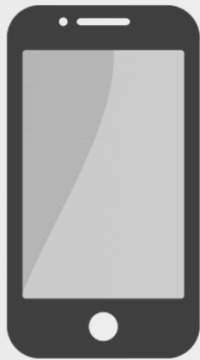

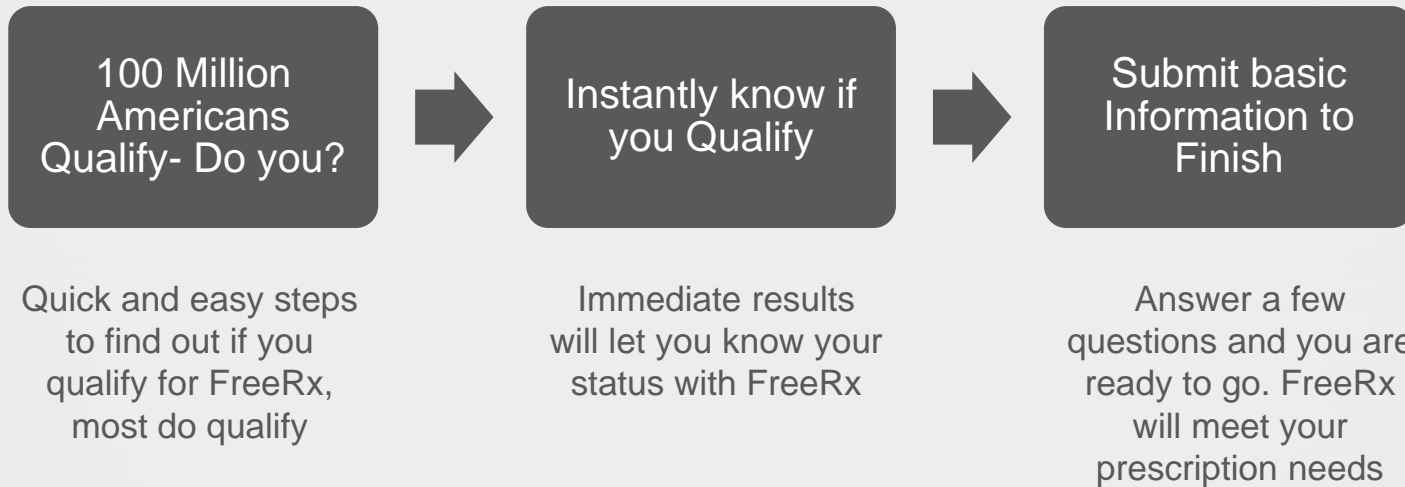

This plan does not meet the minimum creditable coverage requirements under M.G.L. c. 111M and 956 CMR 5.00. This is not a Medicare prescription drug plan or a Medicare Supplement plan. The DMPO benefits provide discounts at certain health care providers for medical services. The plan does not make payments directly to the providers of medical services. The plan member is obligated to pay for all health care services but will receive a discount from those health care providers who have contracted with the discount medical plan organization. The range of discounts available will vary depending on the provider type and services provided. The licensed Discount Medical Plan Organization (DMPO) is Coverdell & Company, Inc., at 8770 W. Bryn Mawr, Suite 1000, Chicago, IL, 60631, 1-800-308-0374. The Member has the right to cancel within the first 30 days for a full refund of discount health benefits paid. The discount health benefits are not available in Vermont, Alaska, Washington, Florida, Rhode Island and Utah at this time. Telemedicine video consultations are not available in the states of Iowa, Louisiana, Missouri, Ohio and Texas. Prescriptions prescribed by a doctor via telemedicine in Georgia and California are limited to three days. Our telemedicine program can effectively treat the majority of the most common diagnoses within this three day limit however.
